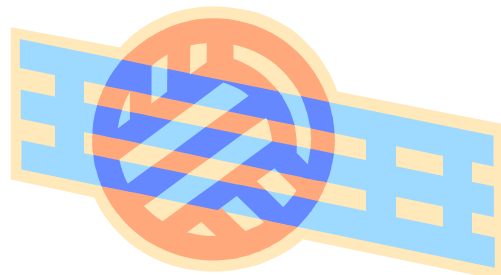
Venue: Sand Volley Australia
